Becoming an Oregon ATV Safety™ Instructor

An Oregon ATV Safety™ Instructor plays an integral role in helping young ATV riders have fun and stay safe while riding on Oregon public lands. An Instructor is a highly qualified individual who is committed to ATV rider safety. By becoming an Instructor, you evaluate the ability of young riders to demonstrate that they can safely operate the ATVs they normally ride. ATVing, as an individual and family recreational activity, benefits through young riders that ride safe, smart, and ethically. Along the way, you

become a better rider too.

Your journey to becoming an Instructor starts with a few steps. It is important that you read through and understand the following material. The Origins of Oregon ATV Safety™

Oregon ATV Safety™ is an ATV rider endorsement program developed in 2010 by the Oregon 4-H Youth Development Program at Oregon State University through a contract with the Oregon Parks and Recreation Department. Oregon ATV Safety™ is a response to the rising number of ATV related injuries and deaths and Oregon Administrative Rule (OAR) 736-004-0085 (2) (d). This OAR requiring ATV riders in Oregon, less than 16 years of age, to possess an operator's permit and endorsement of hands-on course completion started January 1, 2012.

The objectives of Oregon ATV Safety™ are to provide youth with an understanding of the risks associated with riding ATVs and an understanding of the minimum riding standards that can help youth manage and minimize risks.

Oregon ATV Safety™ Instructors use ranges that have been pre-approved for use by Oregon ATV Safety™ and facility owners. Instructors live and work within the county they serve to provide endorsements.

Oregon ATV Safety™ Youth Rider Endorsement Program

The Oregon ATV Safety™ Youth Rider Endorsement Program course is an opportunity for youth to demonstrate to a highly qualified ATV professional that they have the basic skills necessary to operate an ATV on Oregon public lands.

The objective of Oregon ATV Safety™ is to provide youth with an opportunity to demonstrate their mental and physical riding skills necessary to meet the minimum standards to operate an ATV on public lands.

On the Youth Rider Endorsement Program range, you will demonstrate the minimum standards. The Oregon ATV Safety™ program wants young riders to be successful. Your job, as an Instructor, will be to make sure the course is fun and safe. The goal of the endorsement program is to see that youth receive the hands-on endorsement necessary to ride on public lands.

Expectations of Oregon ATV Safety™ Youth Rider Endorsement Program Instructors

Oregon ATV Safety™ is looking for Instructors who have a genuine interest in helping young riders; Instructors who can and will listen to young people and be sensitive to their needs.

Oregon ATV Safety™ Instructors are expected to present themselves in a professional manner anytime they may be recognized as being associated with Oregon ATV Safety™. As a representative of Oregon ATV Safety™ it is incumbent upon you to ride and act responsibly.

There are specific expectations/requirements for our OAS Instructors:

- Model safe riding behaviors – Instructors are expected to wear appropriate riding gear (DOT approved helmet, eye protection, long sleeves, full length pants, full finger gloves and footwear that covers the ankles) in their personal life and in their Instructor capacity. Instructors are recognized as ATV safety professionals in their communities. It is essential that Instructors protect their credibility and that of the Oregon ATV Safety™ program by dressing appropriately and riding responsibly any time they ride.
- Maintain skills to effectively demonstrate exercises - The demonstration rides given during a course are not necessarily skills used in everyday trail riding. Therefore, Oregon ATV Safety™ expects the Instructors to spend the appropriate time practicing so they can give the students a correct demonstration the first time.
- Required to facilitate a minimum of 4 training/evaluation courses (estimated 2-3 hours each).
- Attend update training as requested or required. Attendance is highly recommended for the Instructor's benefit.
- Follow Oregon ATV Safety™ approved curriculum; comply with policies and procedures - protect yourself and the program.
- Maintain a good driving record - Protect your ability to train/evaluate. If an individual receives two tickets in a 12-month period, (or 3 in 18 months) they will be suspended from evaluation and placed on probation for one year from the date of the last moving violation.

Oregon ATV Safety™ Prerequisites

The following requirements must be met before Oregon ATV Safety™ can consider an individual's application.

- Must be 21 years of age/older
- Must successfully pass criminal background check
- Must be an experienced ATV rider who currently holds an Oregon All-Terrain Vehicle Safety Education Card
- Must have an acceptable driving record - no suspensions, cancellations, revocations or denials within preceding 3-year period - See expectations above regarding driver's license.
- Must have no felony convictions
- Must be in good physical shape, capable of sustained physical exertion - Classes take place anytime the Instructor deems the conditions are appropriate to hold a class (usually on a Saturday and/or Sunday). The Instructor should expect to spend from 5 to 9 hours each day (depending on the number of classes offered) with very few, short breaks. Instructors must be able to bend over repeatedly, push ATVs for short periods with students aboard, move quickly (jog, not run) when needed, etc. The weather conditions are rarely ideal. Typically the temperature is cold or hot, when it's cold it is frequently raining (yes, Oregon ATV Safety evaluates, rain or shine).

You need to ask yourself; if I'm worn out after a day like this, is one night sufficient time for my body and mind to recuperate? Remember, the requirement is for the Instructor to provide the same level and quality of instruction at the end of the Sunday session that they provided at the beginning of the Saturday session. You don't need to be Superman or Superwoman, but it is physically and mentally demanding.

- Must complete an Oregon ATV Safety™ application.

Only when all the prerequisites have been met will an individual's application be considered for selection to attend Oregon ATV Safety™ Instructor training.

In the months prior to Instructor training, interviews may be held. If Oregon ATV Safety™ feels an interview is warranted, one will be scheduled. The interviews typically last 20 to 30 minutes and are done over the phone.

The First Step to Becoming an Oregon ATV Safety™ Instructor

Oregon ATV Safety™ Instructors are expected to continue to grow and hone their skills throughout their careers. They must be willing and able to accept coaching and adjust their delivery as long as they are a member of the team.

Becoming an Oregon ATV Safety™ Instructor requires an eight hour training.

The steps are as follows:

1. Youth Rider Endorsement Program Class Facilitation,
2. Youth Rider Endorsement Program Range Facilitation,
3. Youth Rider Endorsement Program Practicum, and
4. Youth Rider Endorsement Program Instructor Assessment

Learning Oregon ATV Safety™ Course Facilitation and ATV Rider Evaluation

Your success as an Instructor on the range will depend in part on your understanding of the ages and stages of youth development. That is, you will need to know something about the young people you will encounter in your Instructor capacity. A young person's interaction with a myriad of biological, psychological, social, historical, and cultural factors influence how he or she develops. While it is not the mission of Oregon ATV Safety™ to turn you into a youth development professional, it is a goal of Oregon ATV Safety™ to provide each Instructor the facilitation and ATV rider evaluation skills necessary for a successful and enjoyable experience.

You will never be alone as an Oregon ATV Safety™ Instructor. You will always have access to a wide range of highly qualified ATV and youth development professionals to answer your questions, offer guidance, and provide advice.

Oregon ATV Safety™ Quality Control

Oregon ATV Safety™ Instructors are constantly challenged to improve their knowledge and techniques.

One of the tools Oregon ATV Safety™ might use to help the Instructor improve is a Technical Assistance Visit. These are low key, informal visits by an Oregon ATV Safety™ Master Instructor who works with the Instructor during a Youth Rider Endorsement Program course. The Master Instructor will point out areas of good performance as well as making suggestions for potential improvements.

Another tool is the Update. With updates, Instructors learn new techniques, get the opportunity to fine-tune their abilities, and learn to deliver a new curriculum and/or find out what is new or different in ATV training. As previously mentioned, these programs may be offered a number of times each year.

One more tool that might be used is the Site Compliance Audits. Audits are a way of measuring the effectiveness of the program. SCAs are formal visits made by Master Instructors who are looking at the program systems and performance. The Master Instructor observes part of the course and all the facilities and equipment and makes a formal report to the Oregon ATV Safety™ Director.

Benefits of Becoming an Oregon ATV Safety™ Instructor

There are many benefits of being an Oregon ATV Safety™ Instructor. Some are personal, some are tangible.

Youth Rider Endorsement Program Cost Recovery – Instructors give of their time, talent and treasure. The Oregon ATV Safety™ program provides all the necessary equipment to conduct Youth Rider Endorsement Program courses. Oregon ATV Safety™ will replace evaluation equipment and reimburse for materials purchased to facilitate Oregon ATV Safety™ courses.

Tort Liability - Instructors working for a State of Oregon agency (OSU) will be protected from civil liability for injuries or damage to the person or property of others (general conditions apply).
